Always Return Your Ticket or a Copy with payment

TO PLEAD GUILTY AND PAY YOUR FINE:

- a. Sign back of ticket and return it or a copy.
- b. Determine fine from below or by calling number above for assistance. Call if unsure.
- c. **Do Not Send Cash or Personal Check.** Send a cashiers check or money order (in U.S. Dollars) **for the full amount (no partial payments)** payable to **Cass County**. No personal checks will be processed. Use pre-addressed envelope you received or send to address above.
- d. **Write your ticket number and daytime phone number on the front of cashiers check or money order.**

CASS COUNTY TRAFFIC VIOLATIONS FINE SCHEDULE

For offenses not listed, if uncertain of amount, or for questions call: 816-380-8200

- a. **Seat Belt Violations:** If the "seat belt violation" block is completed (see lower left of your ticket above officer's signature) you owe **\$10** for the seat belt violation in addition to the fine for your primary offense.
- b. **Construction/Work Zone Offenses:** Add **\$275** to the amount due if ticket indicates speeding, passing or overtaking in a construction or work zone **with workers present** or add **\$60** on any other tickets that indicates the offense occurred in a construction or work zone.
